- b) Liaise with billing and/or accounting of your hosting and domain service, unless directly provided by Company.
- c) Be responsible for errors and omissions contained in Website content.

4. Additional Services.

Any revisions, additions or redesign Customer wishes Company to perform which is not specified in this document shall be considered "additional" and will require a separate Agreement and payment. Company shall advise Customer on any requested work that falls within these bounds.

5. Entire Understanding.

This contract constitutes the sole agreement between Company and the Customer regarding its Website Maintenance Service. It becomes effective only when signed by both parties.
